Brief Minutes of ISO/TC 136 "Furniture" - Rev.1 ZOOM, 13th May, 2022

1. Opening of the meeting

Mr. FOSSI opened the meeting welcoming all the participants.

18. Any other business

18.1 Drop test – 2 mm rubber pad issue

The issue was discussed during the last plenary meeting and is about the regional differences in the drop test method: in Europe the 2 mm rubber pad is widely used while in US and in China the cement floor is most common. Several attendees (UK, US, China, Australia) also mentioned it was very difficult/impossible to buy this material.

After some discussions ISO/TC 136 members agreed to create a task group to explore the issue and find a possible solution.

The outcome of the Task Group work will be presented at the next ISO/TC 136 Plenary meeting for a final decision on the "rubber pad issue".

18.2 Proposal for changes to ISO 10131 (from CPSC)

Mr. FOSSI informed the members about the request from CPSC (see Doc. N 790) to revise ISO 10131 because of some issues with the mounting instructions.

After some discussions ISO/TC 136 members agreed to wait for the conclusion of the ongoing revision of EN 1129 and then start the revision of ISO 10131 according to the new version of the European standard. US CPSC will be informed of the expected timing and on the progress of this project.
